In the sum of **Four Million Nine Hundred Ninety Five Thousand Pesos Only (P 4,995,000.00)**, hereinafter called the "**Contract Price.**"

WHEREAS, the whole supply and delivery as covered by this Agreement shall be completed within **Thirty (30)** calendar-days in accordance with the provisions of the Bid documents.


NOW THEREFORE, in view of the foregoing premises and of the mutual covenants and stipulations, hereinafter provided, the parties here to have agreed, as follows:

1. In this Agreement words and expressions shall have the same meanings as respectively assigned to them in the Conditions of Contract referred to.
2. The following documents shall be deemed to form and be read and construed as part of this Agreement, viz.:
 - (a) The Bid Form and the Price Schedule submitted by the bidder;
 - (b) Schedule of Requirements;
 - (c) Production/Delivery Schedule;
 - (d) Technical Specifications;
 - (e) General Conditions of Contract;
 - (f) Special Conditions of Contract;
 - (g) Performance Security;
 - (h) Notice of Award;
3. In the consideration of the payments to be made by the **DPWH** to the **SUPPLIER** as hereinafter mentioned. The **SUPPLIER** hereby covenants with conformity in all respects with the provisions of the Contract.
4. The **DPWH** hereby covenants to pay the **SUPPLIER** in consideration of the provision of the goods and services and to the remedying of defects therein, the **Contract Price** or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the day and year first above written.
5. The provisions on liquidated damages under Section 68 and Paragraph 9 of Annex "E" of R-IRR of R.A. No. 9184, are hereby incorporated and deemed to form part of this Agreement. The amount of liquidated damages shall be equal to one-tenth (1/10) of one percent (1%) of the cost of the unperformed portion of the works for every day of delay.
6. The **DPWH** shall terminate a contract for default when due to the SUPPLIER's fault and after the contract time has expired.
