WHEREAS, the Department of Public Works and Highways advertised on May 21, 2025 the Invitation to Bid for SUPPLY AND DELIVERY OF IT OFFICE SUPPLIES FOR USE IN THE BRT PROJECT, DPWH R.O. 7, SRP, CEBU CITY, with an Approved Budget for the Contract (ABC) of Php 1,460,500.00 in the DPWH website, PhilGEPS and at a conspicuous place in the premises of the DPWH continuously for seven (7) consecutive days.

WHEREAS, in response to the said advertisement **one (1)** prospective bidder, purchased bid documents for the said bidding;

WHEREAS, the representative of COPIER SOURCE ENTERPRISES attended the Pre-Bid conference on May 29, 2025;

WHEREAS, during the Submission and Opening of Bids on June 10, 2025, COPIER SOURCE ENTERPRISES submitted their bid document;

WHEREAS, the eligibility and technical component envelope of lone bidder were opened and "PASSED" the eligibility check and were rated "eligible". The technical proposal of the bidder were rated as "complying and responsive";

WHEREAS, the financial bid proposal of COPIER SOURCE ENTERPRISES were opened which read:

WHEREAS, the evaluation of the technical component envelope of lone bidder were found to be compliant to the DPWH requirements;

WHEREAS, the BAC-TWG, after a thorough evaluation, recommended to the BAC to award the contract SUPPLY AND DELIVERY OF IT OFFICE SUPPLIES FOR USE IN THE BRT PROJECT, DPWH R.O. 7, SRP, CEBU CITY, whose bid were found to be the Single Calculated and Responsive Bid as shown below:
