BAC RESOLUTION DECLARING FAILURE OF BIDDING
RESOLUTION NO. 29 Series 2025

WHEREAS, the DPWH-Baguio City District Engineering Office advertised the above stated contract through an Alternative Method of Procurement under Small Value Procurement (Section 53.9) and posted at DPWH-Website, Phil-Geps and conspicuous places at the premises of DPWH-BCDEO from May 30, 2025 to June 3, 2025 and thru distribution to the prospective bidders the Request for Quotation (RFQ) No. 25-05-017 dated May 30, 2025 under Purchased Request No. 25-05-110 dated May 23, 2025 with an Approved Budget for the Contract (ABC) of Nine Hundred Eighty Nine Thousand Nine Hundred Sixty One Pesos and Forty Five Centavos (Php989,961.45). The Head of Procuring Entity (HOPE) approved through BAC Resolution No. 25GPD17 dated May 30, 2025 to undertake an Alternative Method of Procurement under Small Value Procurement (Section 53.9);

WHEREAS, the BAC through Secretariat sent a Request for Quotations (RFQ) for the procurement of the above-cited Contract to the following: a) **HDG Construction & Enterprises**, b) **EDEL Enterprises**, and c) **DAPLI Enterprises, OPC**;

WHEREAS, during the conduct of the preliminary examination of their technical components it was noticed that the contract name specified in their Bid Envelopes were not correct, it is the *Procurement of materials for the Maintenance, Repair and Rehabilitation of Infrastructure Facilities and Other Related Activities for the Routine Maintenance of National Roads: Asphalt Cement (Penetration Grade 85-100) and Key Aggregates. (Act. No. 112,114,121,113,122)*. Upon verification, it was confirmed that the contract name stated in the RFQ which was given to them is really incorrect, it should be Procurement of materials for the Maintenance, Repair and Rehabilitation of Infrastructure Facilities and Other Related Activities for the Routine Maintenance of National Roads: **Premix, Hot Laid and Emulsified Asphalt (Activity No. 111,112,114 and 121)**, hence, the BAC did not continue to open their bids.

NOW, THEREFORE, we the Members of the Bids and Awards Committee (BAC), hereby **RESOLVE** as it is hereby **RESOLVED**:


- a.) To declare a failure of bidding because no interested bidder/bidders purchased Bidding Documents for the above stated contract;


