JUSTIFICATION:

The physical target has decreased by 1.106 lane km. from 5.560 lane km to 4.454 lane km due to costing on massive Earthworks (23.09%) and Surface Course (50.18%) of the total project cost. Also, the inclusion of all design features to conform with D.O. 11 series of 2015 and the allocation/reserved payment for the Road Right of Way acquisition. Further, to correct the spelling of the location from Sibutan Road to Sibutad Road and to specify the exact station limit of the said project based on the actual field survey. Thus, the modification is requested.

Attached are the required documents, such as BP202, Certificate of Availability of Funds (CAF), Program of Works (POW), Evaluation Form (2017 Version 2.1), Certificate of Reasonableness, Approved Plans and Geotagged Photos.

In view of the above, the request for Modification of the project is respectfully recommended for consideration and approval.
