Change in type of work from "Construction of Concrete Road" to "Replacement of Bridge" to suit based on the project description and to correspond to the actual scope of work in the implementation of the project providing enhanced accessibility in the transportation of people, goods and services.

2. Based on the plan and actual site condition, the project involves replacement of bridge (4 lane concrete bridge) supported by 40 precast concrete piles driven including road widening with paving of shoulder, construction of slope protection structures (stone masonry) to stabilize the slope and prevent erosion and miscellaneous structures such as installation of road signs and solar street lights for road safety purposes.
