## JUSTIFICATION:

The modification was requested because of the decrease in physical target by 89 lm (from 350 lm to 261 lm) due to the design of the revetment which is rubble concrete on 10 meter- length RC sheet pile foundation. Said design was based on the hydrology/hydraulic analysis and geotechnical investigation. Moreover, modification is sought for the deletion of "and Barra" in the location of project because the construction of revetment will no longer extend farther downstream traversing Brgy. Barra since the physical target of the project was reduced.

Attached are the required documents, such as Evaluation Form (2017 version 2.1), BP202, Program of Work, Location Map, Certificate of Availability of Funds (CAF) and Geotagged Photos.

In view of the above, this request for Modification of Project is respectfully recommended for your consideration and approval.
