JUSTIFICATION:

Modification is requested due to the adjusted station limits based on the result of actual survey. The physical target was increased by 19,786.30 sq.m. (from 999 sq.m. to 20,785.30 sq.m.) in order to maximize the utilization of the FY 2017 allocated funds.
