JUSTIFICATION:

Modification is requested to changed/correct the erroneous location from "Brgy. Pilar, Zambanga, Diplahan, Zamboanga Sibugay" as reflected in the FY 2017 GAA to "Brgy. Pilar, Diplahan, Zamboanga Sibugay". The station limits was adjusted based on actual survey and the physical target increased from 160 lm to 166 lm as a result of maximizing the utilization of allocated funds and the actual need of this project.
