The modification is requested due to changes in station limits which resulted to the decrease in physical target by 0.0224 lane km (from 5.738 lane kms. to 5.7156 lane kms.), because of the increased cost of Subbase Course which constituted (26.15%) and Surface Course (56.85%). Also, the inclusion/reserved payment for Right-of-Way acquisition which was not provided in the FY 2017 GAA, thus, the request for modification is necessary.

Attached are the required documents, such as BP202, Certificate of Availability of Funds (CAF), Program of Work (POW), Evaluation Form (2017 version 2.1), Certificate of Reasonableness, CY 2015 RoCond Data, Approved Plans and Geotagged Photos.

In view of the above, the request for Modification of the Project is respectfully recommended for consideration and approval.
