JUSTIFICATION:

The modification is requested to specify the exact/correct station limits of the project as a result the physical target decreased by 658.00 Im (from 1,300.00 In.m to 642.00 In.m.). The reduction were due to the cost of Earthworks such as Common Excavation and Embankment which accounts 28.25% (P 27,190,642.58) of the total cost of the project coupled with the high prices of construction materials, i.e. Fine Aggregates, Course Aggregates, Cement, RSB and etc., based on the Price Monitoring Data submitted by the District Office plus hauling distance to the project site. Further, also the inclusion/reserved payment for the RROW acquisition which was not provided in the FY 2017 GAA. Thus, the reasons for the reduction in the physical target.

Attached are the required documents, such as Evaluation Form (2017 version 2.1), BP202, Program of Work, Location Map, Certificate of Availability of Funds (CAF) and Geotagged Photos.

In view of the above, the request for Modification of the Project is respectfully recommended for consideration and approval.
