JUSTIFICATION:

The Modification is requested to specify the exact station limits based on actual field survey. The physical target was decreased by 1.448 lane km. (from 3.330 lane km to 1.882 lane km) due to costing on massive Earthworks (48.69% = Php 23,369,666.35) and Surface Course (27.66% = Php 13,277,853.71) and the inclusion of all design features to conform with D.O. 11 series of 2015. Also, an allocation/reserved payment for the Road Right of Way acquisition which was not provided for in the FY 2017 GAA.

Attached are the required documents, such as BP202, Certificate of Availability of Funds (CAF), Program of Works (POW), Evaluation Form (2017 Version 2.1), Certificate of Reasonableness, Approved Plans and Geotagged Photos.

In view of the above, the request for Modification of the project is respectfully recommended for consideration and approval.
