## JUSTIFICATION:

The modification is requested to indicate the actual station limits and locations based on actual validation, considering the extent of slope failures experienced after heavy downpour, and disintegration of trees and saplings in the area due to logging operations as this is under the Integrated Forest Management Area (IFMA). As a result, final design of some sections were also changed from the conventional Grouted Riprap and Masonry Type to Reinforced Concrete due to stiff slopes and considerable deep height.

Attached are the required documents, such as Evaluation Form (2017 version 2.1), BP202, Program of Work, Location Map, Certificate of Availability of Funds (CAF) and Geotagged Photos.

In view of the above, the request for Modification of the Project is respectfully recommended for consideration and approval.
