JUSTIFICATION:

The physical target has decrease by **1.662 lane kms.** (from **8.202 lane kms.** to **6.54 lane kms.**) due to **costing on massive earthworks** (44.50%) and **Surface Course** (31.28%), among others, coupled with actual hauling distance of aggregates, as well as the inclusion/reserved payment for Road Right-of-Way acquisition which was not provided for in the FY 2017 GAA.

Attached are the required documents, such as Evaluation Form (2017 version 2.1), BP202, Program of Work, Location Map, Certificate of Availability of Funds (CAF) and Geotagged Photos.

In view of the above, the request for Modification of the Project is respectfully recommended for consideration and approval.
