Justification: Modification of the project title is being sought in view of the urgent need to complete the two (2) unfinished Multi-Purpose Buildings at Rancho IV, Brgy. Concepcion Dos and Angel Santos St., Brgy. Tumana, both in Marikina 2nd LD for safety and security reasons.
