The modification is requested **to specify the actual station limits** based on actual field condition, were physical target increase by **0.13584 lane km.** (from **3.03 lane kms. to 3.16584 lane kms.**), as a result of **maximizing the utilization of fund**, and the inclusion/reserved payment for Road Right-of-Way acquisition which was not provided for in the GAA.
