JUSTIFICATION:

The physical target has **increased** by **2.44 lane kms**. (from **4.60** lane kms. to **7.04** lane kms.) because the cost of aggregates was substantially **reduced due to availability near the vicinity of the project site**. Further, the said allocation covers the requisition of the RROW with an estimated area of 1,226,22 sq.m.

Attached are the required documents, such as Evaluation Form (2017 version 2.1), BP202, Program of Work, Location Map, Certificate of Availability of Funds (CAF) and Geotagged Photos.

In view of the above, the request for Modification of the Project is respectfully recommended for consideration and approval.
