JUSTIFICATION:

The physical target has slight increase by **0.09 lane kms.** (from **9.74 lane kms.** to **9.83 lane kms.**), due to minimal cost of Earthworks which is only 12.21 % (P 16,997,415.96) of the total project cost, as well as the inclusion/reserved payment for Road Right-of-Way acquisition.

Attached are the required documents, such as Evaluation Form (2017 version 2.1), BP202, Program of Work, Location Map, Certificate of Availability of Funds (CAF) and Geotagged Photos.

In view of the above, the request for Modification of the Project is respectfully recommended for consideration and approval.
