JUSTIFICATION:

The modification is requested to specify the actual station limits wherein the physical target decrease by 2.052 lane km (from 7.641 lane km to 5.589 lane km) due to the cost of **EARTHWORKS** which constituted **42.70%** (P 41,202,637.90) of the total project cost that requires **MASSIVE ROCK EXCAVATION** because the existing horizontal and vertical alignments do not meet with the DPWH Design Guidelines and Criteria. It is informed that completion of this project is necessary in order to construct a safe and comfortable road for the riding public.

Attached are the required documents, such as Evaluation Form (2017 version 2.1), BP202, Program of Work, Location Map, Certificate of Availability of Funds (CAF) and Geotagged Photos.

In view of the above, the request for Modification of the Project is respectfully recommended for consideration and approval.
