JUSTIFICATION:

The modification is requested **to specify the correct station limits** due to actual field survey of the project resulting that the physical target was decreased by **445.70 Im (from 970.00 Im to 524.30 Im.)** due to the cost of **Earthworks of 17.36%** of the total project cost and inclusion of other design features in order to produce mitigation measures for safety to the community. Also, the inclusion/reserved payment for RROW acquisition.

Attached are the required documents, such as Evaluation Form (2017 version 2.1), BP202, Program of Work, Location Map, Certificate of Availability of Funds (CAF) and Geotagged Photos.

In view of the above, the request for Modification of the Project is respectfully recommended for consideration and approval.
