JUSTIFICATION:

The modification is requested **to specify the exact/correct station limits** of the project which was not provided in the FY 2017 GAA. The physical target was slightly decreased by 0.318 lane km (from 6.668 lane km to 6.350 lane km) due to the cost of Earthworks which is 10.24% (P 9,595,717.11) of the total project cost and the inclusion of drainage and Slope Protection Structures resulting to reduction of the physical target.

Attached are the required documents, such as Evaluation Form (2017 version 2.1), BP202, Program of Work, Location Map, Certificate of Availability of Funds (CAF) and Geotagged Photos.

In view of the above, the request for Modification of the Project is respectfully recommended for consideration and approval.
