**JUSTIFICATION:**

The modification is requested **to specify the exact/correct station limits** of the project which was not provided in the FY 2017 GAA. The physical target was decreased by 4.32 lane km (from 10.00 lane km to 5.68 lane km) due to the cost of **Earthworks** which is **29.87% (P 42,216,386.52)** and **Surface Course 33.93% (P 47,960,452.95)** of the total project cost plus the hauling distance of 47.00 kilometers to the project site resulting to reduction of the physical target.

Attached are the required documents, such as Evaluation Form (2017 version 2.1), BP202, Program of Work, Location Map, Certificate of Availability of Funds (CAF) and Geotagged Photos.

In view of the above, the request for Modification of the Project is respectfully recommended for consideration and approval.
