## JUSTIFICATION:

The modification is requested **to indicate the correct station limits** of the project, after the conduct of Detailed Engineering Activities, the bridge requires only 880.924 sq.m, as a result the **physical target was decreased by 92.076 sq.m (from 973.00 sq.m to 880.924 sq.m.).** Also, the scopes of work include the concreting of both approaches with a total length of (27.66 lm) and Construction of River Control Structures (100.00 lm).
