## JUSTIFICATION:

Modification is requested to provide specific station limits and the decreased in the physical target from 0.836 lane km to 0.1745 lane km because the original cost of  $\triangleright$  1,255,980.86/Lane Km is not enough to construct the whole stretch, since this is too low compared to the acceptable range of unit cost of the Department. Thus, the request for modification is necessary.

Attached are the required documents, such as BP 202, Certificate of Availability of Funds (CAF), Approved Program of Work (POW), Approved Budget for the Contract (ABC), Evaluation Sheet for Modification (2017 version 2.1), Certificate Reasonableness, Straight Line Diagram, Approved Plans and Geotagged photographs.
