JUSTIFICATION:

Physical target was decreased from 9.8 lane km to 2.2 lane km resulting to the huge volume of earthwork (Common excavation = 104,368.35 cu.m. or 59.39% and rock excavation = 11,950.49 cu.m. or 15.95%) . Further, the said project has a bridge component equivalent to 961.632 sq.m. (100.80 lm).

Attached are the required documents, such as Evaluation Form (2017 version 2.0), BP202, Certificate of Availability of Funds (CAF), Approved Program of Work, Straight Line Diagram and Geotagged photographs.

In view of the above justification, the request for Modification of the Project is respectfully recommended for the Honorable Secretary's approval.
