## Reason/s for Modification

This modification
This modification is sought due to the Final Detailed Engineering Design wherein the physical target in CW1 was change from 13.880 lane-km to 5.6 km because the limit from Sta. 0+000 – Sta. 1+340 is requested for funding for 2017. The said fund will come from the terminated contract of Reconstruction of C-6 project under contract with Yakal Construction.
The Sta. 4+140 to Sta. 6+940 was already funded under 2017 Infra. Program (VIILP).
The Scope of Work was also changed from rehabilitation of concrete road to reconstruction raising of grade, which is necessary in order that the finished grade elevation will be the same with the finished elevation of the op-going widening (Sta. 1+500 to Sta. 6+940).
In CW2 change of physical target from 9.720 lane-km to 3 lane-km because Sta. 1+500 to Sta. 6+940 is already funded under 2016 which is necessary in of the 2 components is justifiable since CW1 component cost of P32.168M/lane-km includes stone masonry and the raising of grade with 1.5m embankment, and CW2 component cost of P56.019M/lane-km includes sheet piling works because the widening of road was within the coastline of Laguna de Bay and also in order to prevent scouring.

Finding the herein request for modification in order, it is respectfully recommended to the Secretary for his consideration and approval.
