JUSTIFICATION:

The physical target is shortened by 2,248 sq.m. (from 29,272 sq.m. to 27,024 sq.m.) due to the inclusion/provision of 2,834 lm sidewalk with curb & gutter and 6,800 lm – 910mm dia. RCPC which are deemed necessary for public safety and to accommodate water run-off.

Attached are the required documents, such as Evaluation Form (2017 version 2.0), BP202, Program of Work, Location Map and Certificate of Availability of Funds (CAF).

In view of the above justification, the request for Modification of the Project is respectfully recommended for the Honorable Secretary's approval.
