JUSTIFICATION:

The physical target for road component was shortened by 0.56 lane km (from 2.24 lane km concrete road to 1.68 lane km gravel road – an opening road with mountainous terrain) because of the huge volume of earthwork (surplus rock excavation = 26,268.28 cu.m. (39.73%) & surplus common excavation = 26,123.89 cu.m. (16.84%)). Likewise, the physical target for the bridge component was also decreased based on the result of the actual field validation. Thus, this request for modification.

Attached are the required documents, such as Evaluation Form (2017 version 2.0), BP202, Certificate of Availability of Funds (CAF), Approved Program of Work, Straight Line Diagram and Geotagged photographs.

In view of the above justification, the request for Modification of the Project is respectfully recommended for the Honorable Secretary's approval.
