JUSTIFICATION:

Construction of parallel bridge which resulted to an increase in length of 139.33 sq.m. (from 870 sq.m. to 1,009.33 sq.m.), after considering the design requirement, harmonizing the road and bridge alignment is more economical than to widen the lanes both sides.

Attached are the required documents, such as Evaluation Form (2017 version 2.1), BP202, Program of Work, Location Map, Certificate of Availability of Funds (CAF) and Geotagged Photos.
