1. Per actual survey, volume of embankment was minimal, hence, there is an increase in physical target of the CW1 (Construction of Gravel Road); and

2. The physical target of the slope protection decreases from 5,714.286 sq. m. to 4,479.665 sq. m. since the 1,234.621 sq. m. was constructed already under the FY 2016 Budget.

Attached are the required documents such as Form for Evaluation of Modification Request (2017, version 2.1); Certificate of Availability of Funds; Approved Program of Works; BP 202; Location Map; and Geo-tagged pictures.

In view of the above, the request for Modification of the Project is respectfully recommended for consideration and approval.
