JUSTIFICATION:

1.) To adopt the terminologies that were indicated in the project title of the approved plans, POW, ABC and bidding documents as taken from the detailed information outlined in the National Expenditure Program (NEP) with Errata which differed from what were reflected in the FY2017 GAA. 2.) The 3rd section shown in the FY2017 GAA has to be cancelled while the length of its first two (2) sections needs to be shortened, which subsequently will introduce changes in its respective station limits, due to the fact that the available fund cannot cope-up in implementing the required slope protection works for the whole stretch originally identified for the project. In determining the new station limits of the two (2) remaining sections, which eventually will be the coverage of the modified project, the basis were actually focused in applying the necessary slope protection countermeasures on the most critical slopes that should be prioritized for inclusion in this project.

Attached are the required documents such as Approved Program of Works, Approved Budget Cost (ABC), Form for Evaluation of Modification Request (2017, version 2.1), Certificate of Availability of Funds(CAF), BP 202, Justification, Straight Line Diagram, Approved GAA 2017 and Geo-tagged pictures.

In view of the above, the request for Modification of the Project is respectfully recommended for consideration and approval.
