Reason/s for Modification

Change/increase in physical target is due to the final design of bridge considering the bridge alignment (curve & skewed) and the maximum flood level. The existing alignment of road is curved, thus the bridge design is skewed.

Furthermore, the bridge elevation has increased considering the observed maximum flood level. The decrease in unit cost is based on the approved POW/DUPA using the prevailing cost of construction materials for pre-stressed concrete bridge on spread footing.

Finding the herein request for modification in order, it is respectfully recommended to the Secretary for his consideration and approval.
