Reason/s for Modification

Increase in the physical target based on the final design of the bridge. The original target published in GAA is based on the estimated area considering only the existing width of river bed. However, during the preparation of detailed engineering design, the length of the bridge has increased due to its alignment (curved), thus requiring widening.

Decrease in unit cost is based on the approved POW/DUPA using the prevailing cost of construction in Catanduanes.

Finding the herein request for modification in order, it is respectfully recommended to the Secretary for, his consideration and approval.
