Justification: <ul style="list-style-type: none">Change of project limit to include road sections that need immediate repair for the safety of commuters/travelers and also to prevent further damage to infrastructure;Revision of the design of slope protection structure from stone masonry revetment wall to a gravity wall with concrete shoulder and drainage canal;The difference of cost is due to the change in the design of the structure and also due to the increase in the cost of materials is caused by the additional hauling cost in the aggregates from Albay to Catanduanes.
