The modification is requested due to increase in physical target from 152.32 square meters to 351.07 square meters based on the results of actual validation considering the existing terrain and to include additional component for the construction of 0.18 lane km concrete road in order to have a smooth surface for the convenience and safe ride of the travelling public.
