Justification: Change in physical target. The actual physical target of the bridge is 158,544 square meters resulting to decrease in cost. The excess amount derived from the bridge will be added to the construction of road. The average hauling distance for aggregate materials from quarry to the project site is 65 kilometers and the station limits were based from the actual survey.
