## JUSTIFICATION:

Modification is requested to consider adjustments in the station limits due to the decrease in physical target from 14,731 sq.m. to 3,291.36 sq.m. to prioritize sections greatly affected by successive typhoons with heavy rains, Typhoon Marce (11/27/2016) and Typhoon Auring(1/18/2017). However, this change is made due to the inclusion in the scopes of work the concrete sheet piles (2,070 lm.) at K1272+460-K1262+600, K1272+680-K1272+747 and paving of shoulders (767.50 sq.m.) to address possible scouring caused by surface water and installation of safety barriers (metal guardrails) for road safety. Also, the inclusion/reserved payment for the Right-of-Way acquisition which was not provided in the FY 2017 GAA.

Attached are the required documents, such as Evaluation Form (2017 version 2.1), Program of Work (POW), Detailed Unit Price Analysis (DUPA), Location Map, Straight Line Diagram, Geotagged Photos, BP202 and Certificate of Availability of Funds(CAF).

In view of the above, the request for Modification of the Project is respectfully recommended for consideration and approval.
