Respectfully submitted is the letter dated 16 March 2017 of OIC Regional Director POL M. **DELOS SANTOS,** of DPWH-XIII, requesting for approval the Modification of Project to be implemented by the said region under the FY 2017 GAA in the prescribed form (2017, version 2.1), to wit:

## Physical Target:

- 4.686 lane km (Concrete Road)

### JUSTIFICATION:

Modification is requested due to inclusion of additional component (1.454 lane km gravel road) and the decrease in physical target of road concreting by 1.454 lane km (from 6.14 lane km to 4.686 lane km) because of the huge quantity of Surplus Common Excavation, Surplus Rock Excavation (Soft) and due to revision of unit cost pursuant to D.O. #197, series of 2016 (Revised guidelines of New ABC). Thus, modification is to be made.

Attached are the required documents, such as Evaluation Form (2017 version 2.1), BP202, Program of Work, Location Map, Certificate of Availability of Funds (CAF) and Geotagged

In view of the above, the request for Modification of the Project is respectfully recommended for consideration and approval.
