Justification : Based on the detailed unit analysis and approved quarterly price monitoring of materials, the physical targets decreased from 1.874 Lane km to 1.003 Lane km. The decreased in length was also due to the increase of cost/km as a result of the increase in hauling distance of aggregate materials from the quarry to project site, (AHD = 57.00kms) hence, the allocation is not sufficient to meet the target length. The change in station limits was based on the RBIA.

Based on our evaluation, the submitted request for modification of the said project is in order; hence, approval hereof is recommended.
