CANLAS,** for and in the absence of the OIC Regional Director, DPWH-XIII, requesting for approval the Modification of Project to be implemented by the said region under the FY 2017 GAA in the prescribed form (2017, version 2.1), to wit:

Modification is requested to identify the exact station limits of the project based on actual field validation. The physical target is shortened by 1.73 lane km. (from 5.73 lane km to 4.00 lane km) due to large quantity of surplus common excavation=35,430.82 cu.m. (7.30%) and surplus rock excavation=69,825.36 cu.m. (15.49%) with stone masonry=2,765.33 cu.m. (11.44%) for slope protection. Also, increase in the percentage used in OCM and CP in accordance with D.O. # 197, S2016 - Revised Guidelines of New ABC.

Attached are the required documents, such as Evaluation Form (2017 version 2.1), BP202, Program of Work, Location Map, Certificate of Availability of Funds (CAF) and Geotagged Photos.

In view of the above, the request for Modification of the Project is respectfully recommended for consideration and approval.
