Justification: Project modification is requested due to the decrease in the physical target. The decrease was due to the increase in the unit cost per square meter of the road slope protection structure (Stone Masonry with Paraphet Wall, Reinforced Concrete Pipe Culvert and Grouted Riprap), updated labor rates, equipment rental rates, and updated construction materials price data. Further, the material source is situated in Baggao, Cagayan which is 58 km from the project site. The updated unit cost is supported by the attached POW and DUPA.

Based on our evaluation, the submitted request for modification of the said project is in order; hence, approval hereof is recommended to the Secretary.
