The physical target for the widening of bridge is increased by 162.32 sq.m. (from 2,041.00 sq.m. to 2,203.32 sq.m.). Also, the allocation of the project is breakdown into component such as acquisition of 2,604.00 sq.m. Right-of-Way/payment of affected improvement/structure along the project limit and construction of concrete road equivalent to 1.20 lane km (0.6 km) total length for both approaches.

Attached are the required documents, such as Evaluation Form (2017 version 2.1), BP202, Program of Work, Location Map, Certificate of Availability of Funds (CAF) and Geotagged

In view of the above, the request for Modification of the Project is respectfully recommended for consideration and approval.
