<ul style="list-style-type: none"> The project comprises slope protection works with a total length of 2.0726 km and sealing of shoulders with a total length of 3.1942 km. The change in section/station limits is due to the exclusion of road sections which are funded by NDRRMC. The increase in unit cost is due to the inclusion of the sealing of shoulder with PCCP which is necessary to block floodwater in seeping into the roadway.
