Modification is requested due to the physical target was increased by 33.50 sq.m. (from 930.00 sq.m. to 963.50 sq.m.). The scope of works include the construction of PCCP for both approaches with a total length of 139.41 meters. Also, the inclusion/reserved payment of RROW acquisition.
