JUSTIFICATION:

There is no change in project limits. However, physical target for off-carriageway (paving of shoulders) was increased by 9,888 sq.m. from 34,776 sq.m. to 44,664 sq.m since the 3rd project limits was considered for paving of shoulders. The said 3rd project limit was originally for reconstruction only to prioritize badly damaged pavement. Considering that the road section runs on a very flat terrain, hence, the excess amount was utilized for the paving of shoulders of the 3rd section. Also, physical target increased for reconstruction from 3.976 lane km to 4.000 km based on design only.

Attached are the required documents, such as Evaluation Form (2017 version 2.1), BP 202, Certificate of Availability of Funds (CAF), Approved Program of Work, Straight Line Diagram, and Geotagged photographs.

In view of the above, the request for Modification of the Project is respectfully recommended for the Honorable Secretary's approval.
