## JUSTIFICATION:

Increase in physical target from 18 lm to 329 lm since the allocation could still cover the needed drainage structures along the road going to the outfall instead of the original scope of work which is box culvert only. The length of the concrete lined canal in Tambongon Section is 110 lm, perpendicular to our national road at K 1782+440 and 196 lm for Mampising Section (11 lm perpendicular to our national road at K 1805+938 and 185 lm at K 1805+909 – K 1806+107). The total length of the concrete lined canal is 306 lm. Limits modified due to said increase in physical target for both the start of the two sections and end limits of the 1<sup>st</sup> section. End limits of 2<sup>nd</sup> section moved 1 meter backwards as per actual need in the site condition.

Attached are the required documents, such as Evaluation Form (2017 version 2.1), BP 202, Certificate of Availability of Funds (CAF), Approved Program of Work, Straight Line Diagram, and Geotagged photographs.

In view of the above, the request for Modification of the Project is respectfully recommended for consideration and approval.
