## **JUSTIFICATION** :

Increase in physical target by 2.0 lane km (from 7.10 lane km to 9.10 lane km) due to the road section runs on a flat terrain, which does not require massive earthworks. Also, change in station limits since widening reckoned/started at K1538+251.531 instead of K1538+261 (decreasing chainage) because K1538+261 is located at junction.

Attached are the required documents, such as Evaluation Form (2017 version 2.1), BP 202, Certificate of Availability of Funds (CAF), Approved Program of Work, Straight Line Diagram, and Geotagged photographs.

In view of the above, the request for Modification of the Project is respectfully recommended for the Honorable Secretary's approval.
