 Change in physical target of CW1- 0.212 lane-km., to revised of 0.79975 lane-km. and an additional component of CW2- construction of drainage along road with 77.00 lineal meters as physical target based on actual detailed engineering and derived quantities and items of works considered in the approved POW.

 Utilization of funds was maximized to cover the lengthening of the project for widening which is also to close the gap between Sn Fernando -Lubao Road and Lubao Diversion at station K0085+660.05 to K0085+702 and inclusion of drainage was considered to establish a continuous flow of water to the outfall preventing the roadway from flooding especially during rainy season.
