



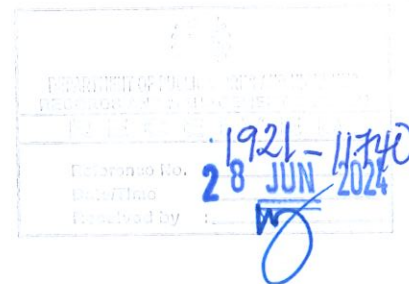

Justification: Decrease in physical target/decrease in unit cost of CW1 – Road Widening from 3.27 Lane Km to 2.102 Lane Km are due to the following: <ul style="list-style-type: none">Inclusion of up to 2 layers of reinforced concrete retaining wall with a height ranging from 1.5meters to 7.0meters to provide structural support and prevent collapse of the roadway as the location of the project is along mountainous terrain.The road widening project involves 280mm thick PCC Pavement, including shoulder at both sides, pre-cast concrete curb and gutter, guardrail, furnishing of seedlings and thermoplastic pavement markings.					



- Inclusion of CW2 - Construction of Road Slope Protection Structure which comprises 40.41% of the total project allocation. The slope protection structures will consist of concrete retaining wall and gabions with the provision of drainage structures.
- Change in station limit is to synchronize the limits with the decrease in the physical target.

Attached are the following supporting documents: Annexure A to Modification Request Form, GIS Map of the Proposed Project Work Location, Certificate of Availability of Funds (CAF), BP Form 202, Certificate of Reasonableness of Cost Estimate, Certificate of "No Overlapping" and "Not Within Warranty Period", Geotagged Photographs, Approved Program of Work (POW) with Detailed Unit Price Analysis (DUPA), Approved Detailed Engineering Plans (DED), and Straight Line Diagram.
