Justification:

- The change in scope of work from construction of gravel road to construction of concrete bridge was made to
 prioritize the provision of bridge for local residents traversing the river within the area. Moreover, the original
 location for the construction of gravel road is situated in an area with significant challenges arising from the
 presence of the MILF group, which could jeopardize the safety of both the infrastructure and its users.
- The project allocation covers the construction of a bridge with 30-meter length Steel H-Piles, including necessary substructures such as Abutment A, and two out of the three piers. Additionally, it covers the superstructures, such as girders, and deck slab for one out of the four spans.
- Since no private properties were affected, the Right of Way (ROW) component is no longer required. The ROW
 component cost was transferred to civil works in order to ensure the quality of the revised scope of work.
- The derived unit cost is based on the approved Program of Works (POW) and Detailed Unit Price Analysis (DUPA).
 See attached Certificate of Reasonableness of Cost Estimate signed and approved by the Regional Director.
