## Justification:

- The change in the scope of work from CW1 Off-Carriageway Improvement: Construction of Laybys to CW1 Off-Carriageway Improvement: Paving of Shoulders is due to the impracticality of constructing laybys attributed to elevated terrain and limited length of approaches leading to Malabbac Bridge.
- The introduction of CW2 Construction of Road Slope Protection Structure, which comprises 38.58% of the project budget allocation, involves the construction of a reinforced concrete retaining wall. This structure, with a height ranging from 1.9m to 4.2m, is specifically designed to address road safety concerns by ensuring slope stability and preventing soil erosion.
- Inclusion of RROW component to compensate the affected lots to avoid delay in the project implementation. The unit cost of RROW is based on the current zonal value established for Redondo, Iguig, Cagayan, as sourced from the database maintained by the Bureau of Internal Revenue (BIR). (Please see attached Zonal Values)
- The change in the station limits is due to the existing widening and shoulder in the original station limits, hence, the consideration of paving the shoulders within the new project limits. (Please see attached Straight Line Diagram)

Attached are the following supporting documents: GIS Map of the Proposed Project Work Location, Certificate of Availability of Funds (CAF), BP Form 202, Certificate of Reasonableness of Cost Estimate, Certificate of "No Overlapping" and "Not Within Warranty Period", Geotagged Photographs, Approved Program of Works (POW) and Approved Detailed Engineering Design (DED).

Based on our evaluation, the submitted request for modification of the said project is in order; hence, approval hereof is recommended.
